This Compliance Assessment Report follows a review of routine monitoring data for the period 1st October 2015 - 31st December 2015 and the 2015 annual returns.

### 1. Leachate Heads

Leachate heads were monitored monthly and compliant throughout the period (<1m).

### 2. Groundwater Quality Monitoring

Monitoring completed as required by permit (Monthly, Quarterly and bi annual suite)

On 29/10/15 a sample collected from monitoring well T10 recorded ammoniacal nitrogen at 2.1mg/l (limit 1.9mg/l). FCC have provided the measurement uncertainty which when applied to the result brings it within compliance. The borehole is due to be subjected to an extended purge prior to the next sampling round.

### 3. Perimeter Gas Monitoring

During monthly monitoring the methane trigger of 1% was not exceeded.

### 4. Surface Water Quality Monitoring

No discharges from the surface water lagoons / grass plots reported during this period.

Samples collected from the River Dee upstream and downstream of the landfill are indicative of a high quality watercourse. No issues noted.

### 5. Annual Reporting

Thank you for submitting information as required by permit condition 4.2.1. The annual review of monitoring data as required by 4.2.1 (a) shall be submitted to NRW by 31st March 2016.
