Reporting of Emission to air, water and sewer Q4 2013/14.

We have reviewed the following quarterly monitoring reports as required by Conditions 2.2.1.3, 2.2.2.3, 2.2.2.8, 2.10.2 of the Permit: Reporting of Emissions to Air, Water & Sewer for the period 1st July 2013 - 30th September 2013.

Monitoring submitted for this period shows no breaches of permitted emission limit values.

No action(s) are required.

Fugitive Emissions Review.

It is noted the old lagoon has been relined, which is expected may yield an improvement in the potential for process water to seep out and into the nearby groundwater aquifers. No new fugitive emission sources have been identified as part of the review.

Review of Site Protection and Monitoring.

The monitoring well MWAFF2 is noted as having raised N levels due to a spill - can you clarify what was material was spilt and if any remedial actions were necessary?

This is the 3rd consecutive year raised N levels are noted around the Dynea Plant and drainage areas. What actions have Dynea taken to ensure there is not a year on year rise in these instances and potential for site contamination? Have the mentioned Urea leaks been addressed?
