- Emission point A5 NAIRB Wet Scrubber – Resin VITS 2, 3, 5 Paper Impregnation Plant monitoring result 9.4 versus 5 mg/m<sup>3</sup> limit (30 minute reference period, annually in triplicate), and
- Emission point A6 NAIRB Wet Scrubber – Resin VITS 4 Paper Impregnation Plant monitoring result 24.6 versus 5 mg/m<sup>3</sup> limit (30 minute reference period, annually in triplicate).

NB: Total VOCs - A5 at 11.9 mg/m<sup>3</sup> and A6 at 28.0 mg/m<sup>3</sup> versus limit of 50 mg/m<sup>3</sup>.

Actions: Kronospan to inspect, clean and maintain the scrubbers as appropriate week commencing 6 February 2016 and then repeat the monitoring. The Part B is then to be resubmitted with the outcome of the investigation and retest results.
