4. Details of our assessment

On Thursday the 16th of June 2022 Boguslawa Pierzchala, waste regulation officer carried out a routine, unannounced inspection.

The weather was dry and sunny.

The officer was met by Mr Richard Tomlinson, site owner. Mr Tomlinson showed the officer around.

The AD plant tanks and feedstock to the plant were checked and there were no signs of any issues- cracks or structural damage.

Waste returns:

Section 4.2.2 of the site permit states that "Within one month of the end of each quarter, the operator shall submit to NRW using the form made available for the purpose, the information specified in the form relating to the site and the waste accepted and removed from it during the previous quarter.

Action Please submit the missing waste returns (Q1 - Q4 2021 and Q1 2022) by the 15th of July 2022

Technical Competence for the site was checked and showed that Mr Tomlinson's certificate expired in August 2019.

Mr Tomlinson said he had recently taken the exam and received an up to date certificate.
