4. Details of our assessment

On Monday the 20th of June 2022 Officers from Natural Resources Wales visited GTR

Aggregates and Recycling Ltd following a large fire on site which started on Sunday evening (19/06/22).

Officers spoke to Paul, transport manager, who showed officers around the site.

He explained that three storage bays had been affected by the fire.



All waste stored there (about 200 tonnes) have been moved out by the fire service and was currently stored by the inert waste piles on non-impermeable surface.



Officers witnessed waste floating in the fire water run-off.





Action: Please remove all fire-damaged waste from non-impermeable surface. The waste needs to be removed from site and taken to a suitably authorised facility. Please comply by Wednesday the 29th of July 2022.

The officers were unable to inspect the site's interceptor. Paul stated that a company had been contacted to attend and pump out the fire water run-off.
