4. Details of our assessment

Tony Bruten attended at Ty Newydd Poultry Unit on 27th June 2022 for a pre arranged permit inspection, he was accompanied by Peter Jones and was met on site by Julian Williams.

There was initially a walk around the site to check on drainage and any dust emission issues, all were good with no non compliances identified. The concrete yards were all in good maintained state.

During the site walk the building of two replacement poultry houses for building 1 and 2 were discussed and the officers viewed the SUDS system that is required by planning.

It was mentioned that once all building work has been completed which may be a few years then a new site plan should be submitted showing new drainage plan.

Inspection of all paperwork then followed and all this was in order with no non compliance identified. The BATS returns submitted in 2021 were checked all in order.

No entry was made to the sheds as officers were keen to maintain best possible Biosecurity during the visit and not carry out any un-necessary risk.

No Non compliances were identified and so no further action required.
