It is noted that all emissions from W1 are below permitted emission limit values (ELV) set within permit BR7321IK.

Data submitted by permitted deadlines.

This return includes slightly elevated suspended solids, this was discussed within the last CAR form (NRW0031619) issued to site on 16 May 2017.

Emissions from ETP point A41 reviewed, it is noted that emissions of Zinc were at a maximum of 2.3mg/l, whilst there are no ELV's set for this point, this value is above that of the ELV of 0.8mg/l at the Broken Bank Drain.

Elevated Zinc discussed during inspection of site on 14 September 2017. Tata are to investigate into why elevated levels of zinc are being detected at this point . To report to NRW by 18 October 2017.
