4. Details of our assessment

Introduction

The objective of this CAR form is to provide Puma Energy environmental recommendations specifically in relation to EPR following a recent intervention conducted by HSE and NRW on 14th June 2022 in relation to the rail sidings incident that occurred on 21st June 2019. A separate COMAH Competent Authority Inspection Report has been produced as this CAR form concentrates only matters relating to the Environmental Permitting Regulations.

NRW feedback

Following on from the incident NRW requires the Operator to ensure it continues to monitor the boreholes in and around the location of the incident. NRW recommends that the Operator reviews the location of groundwater monitoring boreholes to ensure that they have the appropriate coverage considering the groundwater contours.

A permit condition has been included in the Operator's most recent permit variation that states -

3.1.4 Periodic monitoring shall be carried out at least once every 5 years for groundwater and 10 years for soil, unless such monitoring is based on a systematic appraisal of the risk of contamination.

The Operator is required to review its Site Protection and Monitoring Programme (SPMP) to ensure it takes into account the above condition.
