4. Details of our assessment

Following a report of a large number of flies being present at the Roath Docs, Cardiff area, ML and GH attended the Associated British Ports site at Roath Dock Cardiff, Old Clipper Road, Cardiff, South Glamorgan, CF10 4LX on 10 June 2022. The weather was dry and

sunny.

During the visit the officers noted approximately 70 bales with Refuse Derived Fuels (RDF). The bales had few tears, but no waste was sticking out of them. There were several fly traps around the site with approximately 30 dead flies floating in them. The officers met with the operational manager Jason Cooksley in the office. The officers were informed that the ship departed the quay with approximately 3300 RDF bales on Wednesday 9th June.

The officers requested for the Pest Management Plan, which was e-mailed to ML on the same day of the visit.

There were no breaches identified at the time of inspection.
