## Advertisement of a draft determination: Biocatalysts

**Application number:** PAN-011842

**Regulated facility type:** Installation - the Environmental Permitting (England and Wales) Regulations 2016, Schedule 1 installation, Part 1, Section 4.1 Part A (1)(a)(iv) Producing organic chemicals such as organic compounds containing nitrogen (for example amines, amides, nitrous-, nitro or azo-compounds, nitrates, nitriles, nitrogen heterocyclics, cyanates, isocyanates, di-isocyanates and di-isocyanate prepolymers).

**Regulated facility location:** Biocatalysts, Cefn Coed, Parc Nantgarw, Cardiff, CF15 7QQ

The application is for an enzyme production facility classified as a Schedule 1 installation, Section 4.1 part A (1)(a)(iv) activity under the environmental permitting regulations 2016.

The site has met the criteria to be designated as a low impact installation. The only emissions to air are from steam boilers that have a thermal input below 1MWth and local exhaust ventilation. All process water is discharged to sewer.

We are minded to grant the permit. We will only grant a permit if we believe that significant pollution will not be caused and the operator has the ability to meet the

conditions of the permit. Any permit we grant will include appropriate conditions to protect human health and the environment.
