Bioaerosol Monitoring and Compost Action Plan - Review

Site Meeting and Inspection -20th June 2022 - Issues and Proposed Actions

A site meeting and inspection was convened to discuss the implications of revised M9 guidance and the breaches of permit limits for airborne bacteria. In addition, further improvements to the compost action plan were proposed followed by a site inspection. No breaches of permit were recorded on this occasion.

Monitoring stations are placed close to the landfill site road which may be influencing monitoring results. Site propose to limit that effect by suppressing the dust and aerosol on the road by damping down and reducing operations during monitoring periods.

On other sites, FCC have looked at other bioaerosol sources and the wind directions and interferences that would affect representative monitoring. Bio-aerosols travel far less than odour, accepted rule of thumb is 250m from site is the boundary for monitoring of bioaerosol. M9 guidance does give some flexibility – In undertaking this work FCC Consulted with the NRW expert, Cardiff University, and their consultants D&F associates.

Detailed proposals are contained in the compost improvement plan and Include:

Removal of the oversize pile - The oversize pile has now been removed, so site is now shredding green waste straight into a new windrow, which means less time moving material so should be reducing bioaerosol.

Evidence is key to improvement. Upwind monitoring has not shown an upwind issue with bio aerosol

FCC would consider doing a monitoring plan at any potential receptors which has proved useful on other sites.

D&F Consultants think the site dust etc could be affecting the outcome of monitoring for bioaerosols

Following permit breaches on routine bioaerosol monitoring at Llanddulas, FCC have revised the compost action plan and implemented many of the agreed actions in advance of submission to NRW. FCC proposes to undertake the remaining actions in the next few months. Many of the actions have already been implemented as preventative measures to reduce the risk of odours arising from the pad, but may also assist in reduction of bioaerosol breaches.
