This was an unannounced visit.

Weather conditions throughout the visit were dry and sunny.

Appearance of entry

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.



Observations and photos

Site was operational during the inspection with members of the public on site.

Waste was sorted appropriately and bays and storage areas were labelled correctly.



Container storing paint was full, paint was observed outside of the IBC (see pic 1 below). A compliance category 4 has been applied because the paint must be stored in the appropriate IBC and the storage of waste must be in accordance to your environment management system.

The same was observed with the gas bottles (pic 2 below). Gas bottles should be stored

within a cage. please ensure that they are within a cage at all times in accordance to your environment management system.
