### Summary:

On the 8<sup>th</sup> of January at 11:00 Carys Williams (NRW – Environment Officer), Llyr Thomas (NRW – Environment Officer), Llyr Williams (DCWW – Project Coordinator), Richard Williams (DCWW – Dam Safety Inspector) and Mark Jones (DCWW – Dam Safety Assistant Engineer), attended the impoundment removal site at Hafodty Reservoir near Corris, post work-completion. This was done as part of the conditions on the impoundment licence, to inspect the site for any non-compliance. After investigating the site, reviewing the geomorphological report, and receiving photos demonstrating pollution prevention during the working period, no non-compliance was recorded. The impoundment licence can forthrightly be surrendered as no further action is required by NRW.'

### Conditions:

**4.1. Following the drawing specification:** The reservoir has been removed and the river restored approximate to the drawings and plan outlined in the licence. Officers at the site did not measure the specifics of the licence as this was deemed unnecessary partly due to the dynamic nature of rivers and hydrology, and partly due to the restored river now flows where the original channel was. DCWW uncovered evidence of the original channel after dewatering the reservoir and used that as a guide as well as the specification of the licence to restore the river channel (see picture 1,2 and 3 showing the site during and post works).

**4.2. Dewatering, scouring and Ecology:** Dewatering appears to have occurred in a controlled and responsible manner, with no evidence of severe scouring, and pollution prevention in place (see picture 4 and 5 demonstrating 2 desilting tanks and in river silt capturing fences).

**4.3. Ensuring Downstream Flow:** This was achieved as evident by the now abandoned diverting water channels.

**4.4. Intention to Begin Works:** DCWW were in regular contact with NRW.

**4.5. Work Completion:** DCWW notified NRW that the work was finished.

**4.6. No work between end of October- May:** Work was completed before the end of October.

**4.7. Cease Work in case of Emergency:** This was never necessary.
