4. Details of our assessment

Tony Bruten visited the site at 09.50hrs on Monday 11th July 2022 and was met by the owner Howard White.

Inspection of signage and documents at site office. Howard White has recently taken over the running of this site from a previous permit holder. It was noted and identified by Howard that the sign at entry point needed to be updated to include his name and emergency contact number as well as amending the phone number of NRW to 03000653000 this will be completed imminently and so is not recorded as a breach.

All other documentation was onsite for inspection and some amendments will be made to his odour and noise management plans although there have been no complaints recorded or identified at the site and none reported to NRW of Local authority.

All manure is being taken away from site and is recorded, Nitrogen and Phosphate levels in the manure are being tested by Avara following recent media coverage of River Wye high nutrient levels.

At the time of inspection there were no birds on site and all houses were open and clean with new wood shavings down ready for new batch. The permitted number of birds for the site is 60,000.

A site walk was completed, there has been new LED lighting in the one shed to improve energy usage and all drainage both clean and foul appeared in good condition. All concrete appeared in good condition.

There was very little dust present under the side extractor fans with just a small amount under two of the main fans, this was not significant level and will be cleaned up.

There were no non compliances identified and so no further action required.
