4. Details of our assessment

On Wednesday the 29th of June 2022 officers from Natural Resources Wales visited GTR Aggregates and Recycling Ltd following a large fire on site that occurred on the 19th of June 2022.

The weather was dry and windy.

Officers spoke to Jamie, site manager, and Paul, TCM for the site. Both were present throughout the inspection.

The site sprinklers were in operation and a large pool of water was seen at the entrance to the site.

Officers witnessed fire-damaged waste being loaded onto a GTR lorry. Paul informed the officers that the remaining waste is being taken to their sister site in Lancaster and to a local landfill.

Some waste was seen in the storage bays where it had been originally stored.



Paul stated that all waste was to be removed immediately.

One skip of green waste and one skip full of tyres were seen by officers. Again, Paul stated that all waste was due to be taken off site later on that day.

The site interceptor was checked and looked full. We are aware of the ongoing issue with the pumphouse that can impact the functioning of the drainage on site.

Action: Site interceptor requires inspecting and maintaining regularly and emptying when it looks full. Please log these checks/actions in the site diary. For immediate compliance.

During the inspection a rat was seen on the waste piles. We strongly suggest a pest control service is to re-attend the site at the earliest opportunity to address the issue.

Action: Pest control service must be contracted to tackle any vermin issues on site. Please comply by the 15th of July 2022
