4. Details of our assessment

Site inspection to determine compliance with Regulation 36 notice undertaken by Michael Edwards and Sally Wakeford of Natural Resources Wales accompanied on site by site

operator Steven.

Officers noted that improvements have been made to the sites operations and that the site was compliant with the requirements of the notice.

However some non compliances were noted during this inspection.

Site Infrastructure

Under **condition 3.1.2** the engineered site containment and drainage system shall be designed, constructed, inspected, validated and maintained, and shall be fully documents and recorded, to be fit for purpose and meet the standards specified in **Table 3.1**.

During the inspection it was noted that the concrete padding required maintenance in several areas throughout the site. Issues were also identified with cracks in the secondary bund for oil containments.

These have been scored as a **category 3** breach of permit **condition 3.1.2**.

Action - As discussed, no wastes can be stored on the affected areas, until they have been repaired to the standards described in the permit under **Table 3.1**.
