#### 4. Details of our assessment

Form S1, Emissions to Sewer, 1<sup>st</sup> April to 30<sup>th</sup> June 2022, was received on 12<sup>th</sup> July 2022.

The average daily discharge was 48.6m<sup>3</sup> over 63 days, making a total discharge of 3064m<sup>3</sup>. The total discharge and daily discharge were much higher than in Q1 2022. The site operated for slightly more days.

The report is accepted.
