3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 8th July 2022 Natural Resources Wales (NRW) received a Schedule 6 Notification from Kennametal informing them that the emission limit value (ELV) for particulate emissions from emission point A6 had been breached.

The measured value for particulate emissions from emission point A6 during routine monitoring on 14th June 2022 was 152.2+/-4.7mg/m³. The ELV is 25mg/m³. A category 3 non-compliance has been issued; the score will be suspended until the new abatement system is operational. This decision will be reviewed in September 2022.

The new scrubber system for this emission point has been ordered and installation is now planned for August, during Kennametal's annual shutdown. This is significantly later than the original planned date of April 2022, the delay being due to the manufacturer's difficulty in obtaining parts. New drying ovens are due to be installed at the same time. NRW hope that these process improvements will ensure that future emissions to air will comply with the relevant ELV.

Kennametal must ensure that this installation date is met, that the new abatement equipment is operational when manufacturing resumes after the shutdown and that particulate emissions to air from A6 are within the ELV.

Action: Kennametal must carry out additional monitoring, once the scrubber has been commissioned, to confirm that emissions are within the ELV. NRW will expect to see the results of this monitoring before 30th September 2022.
