You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On the 19 June 2022 a discharge from Langland Sewage Pumping Station occurred. The outfall is to a designated bathing water with a Blue Flag. The discharge resulted in a low

level incident, however, there was the potential for a high level incident to have occurred.

A permit to discharge in an emergency is in place at Langland SPS. I believe that this discharge was not compliant with the conditions of the permit in that it occurred due to a soft blockage on the suction end of the pump which does not constitute an emergency.

Condition 2 of the permit states that:

2. The Discharge shall only occur when the sewage pumping station is inoperative as a result of one or more of the following:

- i. electrical power failure not due to the act or default of the Consent Holder, its agents, representatives, officers, employees or servants;*
- ii. mechanical breakdown of duty and stand pumps;*
- iii. rising main failure;*
- iv. blockage of the downstream sewer not due to the act or default of the Consent Holder its agents , representatives, officers, employees or servants;*

And it is not reasonably practicable to dispose of the sewage otherwise, there shall be no undue delay on the part of the Consent Holder in remedying any such failure or breakdown.

The non-compliance has been given a result of C2 (Significant) because there was the potential for it to have had a significant impact or effect on the environment, people and/or property (i.e. potential for High-Significant WIRS).

In addition, it is my understanding that there was a delay in responding to an alarm raised at the pumping station. There is no permit do discharge in storm sewage from Langland SPS so all alarms should be responded to in order to stop a discharge from occurring or minimise the impact of any permitted discharges. Had the alarms been responded to, a discharge may not have occurred.

Any discharges that occur due to rainfall are not permitted.

It is an Offence under Regulation 38 (1) (a) of the Environmental Permitting Regulations 2016 in contravention of Regulation 12 (1) (b) to cause or knowingly permit a water discharge activity without an environmental permit. I have issued a Warning for this Offence.
