4. Details of our assessment

Tony Bruten attended site on Tuesday 12th July 2022, he met with Richard Howat.

Initial discussion regarding registering for Quality Assurance Scheme, Richard Howat provided with a letter explaining the process of registration and how it would reduce NRW visits and annual fees.

The inspection was in form of general walk around site inspection, no entry was made to the sheds.

Since the last visit in 2021 work has now been done on Sheds 1 & 2. With the sheds able to receive birds on two levels, Currently birds only housed on first floor of the house with the ground floor remaining unused at this time. Sheds 3 & 4 were also in use bringing total number of birds on site to approximately 112,000.

There were new side intake fans installed on sheds 1 & 2 with other structural improvements made including a ramp at the rear of the sheds for direct access to first floor, also new feed bins had been installed.

Richard will forward updated site plan for attaching to permit folder.

Drainage on site remains the same. There are plans to lay new concrete between sheds 1/2 and 3/4

The site was in good condition with no non conformances identified and so no further action required apart from submission of updated site plan.
