There are no emission limit values (ELV) for emissions to sewer.

SC1: The ELV for the pH of the scrubber liquor is ≥ 8.5 . The reported pH value is 9.9.

SC2: The ELV for the pH of the scrubber liquor is ≤ 5 . The reported pH value is 2.3.

SC3: The ELV for the pH of the scrubber liquor is ≥ 10 . The reported pH value is 10.1.
