4. Details of our assessment

Schedule 5 Notification - Breach of Permit Limit for Orthophosphate

A Schedule 5 notification received on the 13th July 2022 has shown a breach of permit limit for effluent discharge from your facility into to the Afon Erch. The breach in question on this occasion is for Orthophosphate. This breach was sampled on the 08/07/2022.

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for Orthophosphate is 1.5 mg/l and the value reported was 2.1 mg/l

This breach is above the permitted limit. It is therefore, in the context of this discharge, considered a minor breach.

The CCS score on this occasion therefore is a CCS 3.

ACTION: Continue to monitor and adjust dosing of Poly Aluminium Chloride in conjunction with biological loading and throughput as stipulated on the schedule 5 notification form to ensure compliance with your permit.
