Project name

Conwy to Douglas Pipeline Spill Monitoring Survey

Please provide a brief description of the proposed project, including location.

The Douglas complex, operated by Ente Nazionale Idrocarburi (ENI), is a system of three bridge-linked platforms in the East Irish Sea, approximately 23 km off the coast of North Wales, UK, covering water depths varying from 0 to 29 m. A 12 km long subsea pipeline connects the Douglas platform to the Conwy Platform.

ENI propose to undertake subtidal and intertidal surveys to assess the impacts of an oil spill which occurred following a rupture on the Conwy to Douglas pipeline in proximity to the Douglas platform on the 14th February 2022.

The proposed sampling strategy has been designed to adequately sample the areas which could be potentially impacted by the oil spill providing accurate, up-to-date data on the subtidal and intertidal benthic habitats, communities, and species within reach of the oil spill. Subtidal Sampling will collect benthic grab (triplicate 0.1m² Dual Van Veen grab) samples for subsequent macrobenthic, sediment particle size analysis (PSA) and sediment chemistry analysis at sampling stations across a cruciform design. Seabed imagery will be collected with a Drop-down Camera system at each of the grab sampling stations prior to grab deployment to ensure the target location is clear of any obstruction (e.g., subsea cables) or protected habitat (e.g., Annex I habitats). Whilst most stations are located in English waters, 5 stations are located in Welsh waters. 1 station is location in the Liverpool Bay SPA therefore any potential impact on sensitive habitats will be none/negligible.
