Tata submitted a Schedule 1 Part A and B Notification on 29th March 2018 in respect of a reported exceedance of the W1 emission limit for cadmium and copper on 24th February 2018. A cadmium value of 0.072mg/l had been recorded compared with the limit of 0.05mg/l and a copper value of 0.112mg/l compared with the limit of 0.1mg/l.

Tata have previously registered their concern with NRW regarding the impact of discharges that enter the Tata ditch from the St Modwen's development site as these are not under Tata's control and could be adversely affecting the reported metal levels. However, while the drainage system remains in the existing format NRW can not take this into consideration.

The reported cadmium and copper concentrations are less than 1.5 times the limit value. On this basis a non-compliance for the raised levels has **not** been recorded, in accordance with Table 6.3.3 Note 3 of the permit

Tata should continue to keep the situation under review and report any further levels above the limits at W1 in accordance with the Schedule 1 Notification procedure.
