Monitoring returns for the above dates were submitted to NRW as it is a permit requirement under the following condition:

4.2 Reporting

4.2.1 The operator shall send all reports and notifications required by the permit to Natural Resources Wales using the contact details supplied in writing by Natural Resources Wales.

4.2.2 A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year.

NRW has reviewed the submitted reports and make the following comments. Please respond in accordance with requirements where necessary:

There were no breaches for methane in perimeter gas monitoring boreholes in this reporting quarter, and the site has been balanced judiciously to ensure the site is not over extracted. Please check balance gases which are high but contain very little oxygen. This means that gas is being pulled through waste even at the low suction rates forming areas where the waste is semi aerobic. There may also be surface effect as indicated by extraction pressure in some wells which are switched off at the valve.
