4. Details of our assessment

Tony Bruten and Peter Jones attended on 18th July for a routine annual inspection. On arrival met with owner Gareth Adams who explained to us that he had accidentally double booked inspections and the inspector for Red Tractor was on site in the office examining paperwork.

We agreed not to examine paperwork on this visit and would concentrate on yard inspection for drainage, odour, noise and dust emissions.

Officers informed Garth Adams that he could register for the Quality Assurance Scheme (QAS) and he was handed a letter explaining the scheme and the process needed to enter that scheme, which would mean an inspector such as the one completing the Red Tractor inspection would also complete a form which would be submitted to NRW. and would mean NRW would inspect only every third year.

Visual inspection of yard completed, no entry was made to the sheds as per other visits this year to improve biosecurity in the light of Avian Influenza.

There were no non compliances identified and the yard was in excellent condition.

No further action required.
