Site inspection / meeting with Rob Lavercombe and Matthew Dight of 2 Sisters Food Group discussing recent odour complaints.

NRW received the following complaints -

30/08/17 at 18:03 - "caller visiting Asda at Dowlais Top stating an unbelievable smell also noticed same time yesterday"

01/09/17 at 09:44 - "Odours detected at Asda Store"

01/09/17 at 09:50 - " Odours from St Merryns Meat noticed at Dowlais Top Area"

01/09/17 at 12:51 - " odour from 2 Sisters food factory said it was bad last night and then today - rotting smell"

NRW discussed the odour complaints with the complainants on the 1st September and they confirmed a farmyard type smell. Furthermore NRW attended the Dowlais Top area also on the 1st September and confirmed an odour from 2 sisters food Group (Lairage / Farmyard smell).

Based on NRW's investigation a Permit non-compliance has been issued on this occasion as the odour was substantiated off site by an authorised officer of NRW.

From our discussions during this meeting it was evident that a more detailed on site investigations needs to be undertaken when an odour complaint is received. NRW need to have a detailed comprehensive investigation to be undertaken with precise source / root cause of the complaint to be established to prevent a reoccurrence

Therefore, in order to speed up this process NRW have now set up an automatic email notification to you and the site when a complaint is received. This will enable you to undertake your investigation immediately.

You also confirmed that you were going to undertake a review of odour complaint investigations with staff and security staff, we look forward to receiving an update from you by Friday 29th September 2017
