- Discussed recent fuel spill on site and inspected incident area. Noticeably the barrier protection was damaged which caught and ruptured the fuel tank. 2SFG are in the process of moving the barrier to able more access for vehicles.
- The oil inceptor is also to be relocated for access difficulties. And a new slice gate is to be installed.
- On reviewing this incident NRW acknowledges the actions the site took to minimise the pollution risk of the receiving watercourses. Furthermore, your actions resulted in no pollution of the environment.
- However, you must be mindful that you need to inform NRW immediately when such an incident occurs. NRW understands that this is a procedure on site and was not followed during this incident. On this occasion NRW will not be issuing any permit non-compliances but if any reoccurrences occur we will be issuing two Permit non-compliances (General Management and failing to notify NRW).
- Our decision is based on the commitment you have made to review your incident management procedures and retrain staff. We will also plan an incident exercise once this has been completed.
