This Compliance Assessment Report follows a review of routine emissions monitoring returns for the period 01/01/22 - 31/03/22.

No emission limit exceedances were recorded for emissions to air, surface water or emission point E1 (incinerator transfer to effluent plant).

All returns received on time with the exception of Emissions to Sewer - received 06/05/22. This is a breach of permit condition 4.2.3 (CCS4). Please ensure returns are submitted on time,
