On the 11th of August, 2019, I conducted a routine inspection of Welsh Water Pumping Station, permit number: AG0009501. The weather at the time of the inspection was dry.

The pumping station has a history of spilling, with CAR forms issued in August of 2013 and January of 2014 following incidents reported to Natural Resources Wales from the public. As a result of these incidents, a misconnection survey was carried out, a new mesh screen installed as well as a cello monitor to record flow into the station.

During my visit, the works appeared to be operating with no issues. There was no discharge from the outfall. The metal screen installed on the brick outfall was pulling the bolts out, creating gaps at the sides. There was evidence of tissue and rag on the screen and the banks around the outfall.



Actions

- Submit data on the number of emergency discharges at the pumping station and reasons for discharge.
