On 14th February 2018 Slicker were burning pallets on the adjacent "Prismo" site. They were visited by Newport Environmental Health who informed them that they were committing an offence. The fire was immediately extinguished and the remainder of the waste disposed of properly. Slicker informed Natural Resources Wales the next day and submitted a Schedule 6 Notification.

The Prismo site is not permitted and so no action could be taken under either of Slicker's EPR permits. However, it did highlight quite a serious weakness in Slicker's procedures for dealing with waste generated by the business, as opposed to the waste treatment operations.

Several actions have been taken as a result

1. Employees were reminded, as part of the regular "toolbox" meetings, that it is illegal to burn anything on site;
2. A Non-Conformance Report (Slicker internal document) was raised;
3. Slicker internal procedure "Waste generated on site" Version-018 1.1 has been amended to emphasise that no waste is ever to be burned on site.

All the requested actions have therefore been completed very promptly.
