The purpose of this visit was to hand over the site regulation from Gwyn Jones to Rebecca Green, due to the re-organisation of the compliance function within Natural Resources Wales, (NRW).

Eco Oil has been acquired by Hydrodec and the two companies are in the process of merging the businesses. There have already been some personnel changes and there may be more, but Hydrodec will ensure that there is always adequate technical competence available on site.

We were assured that NRW would be kept informed of all relevant changes.

There was a site tour/inspection after a brief office meeting. The site was clean and tidy and the concrete pan, though worn in places, appeared to be in generally good condition. Bunding around the tank farm was constructed from infilled concrete blocks and seemed adequate. Buildings housing various other operations were clean and tidy and in good condition.

Hydrodec would like to consolidate their Waste Management Licence and Environmental Permitting Regulations (EPR) permit and to add storage of EWC 20 01 21* to the EPR permit so that they could take and store used fluorescent tubes. At the same time the permit should be reviewed by NRW to ensure that it complies with the Industrial Emissions Directive (IED). The main activity will need to be changed to 5.3A(1)(a)(ii) and a storage activity (5.6A(1)(a)) added.
