Forms WaterUsage1 and Energy1 for 2017 were received on 26th February 2018.

The Annual Reports for the installation (ZP3334AQ) and the waste transfer station (MB3290HT) for 2017 were received on 26th February 2018.

All the reports are accepted.

Slicker are reminded that these reports should be submitted by 31st January each year. Late submissions will, in future, result in a Cat 4 non-compliance being issued.

Production

Production volumes for oil and rags were both less than in 2016. Oil volumes were more than 40% down and 25% less rags were accepted onto site.

Energy Usage, 2017

Overall electricity use was 22% less than in 2016 and 46% less gas oil was used than in 2016. Primary energy use fell by 40%, but increased slightly when calculated per tonne of oil.

Water Usage, 2017

Overall water usage increased slightly compared with 2016, but when expressed per unit of production the increase was much greater at more than 80%.

Annual Report, Installation, ZP3334AQ, 2017

The annual improvement targets were achieved. Overall production volumes were less than in 2016, making some of the resource use figures actually more per tonne than in 2016.

There were no fugitive emissions from the site, although there was a skip fire in May. Fortunately it was discovered and extinguished quickly. All the fire water was contained and there was no risk to the environment from this or from smoke emissions.

No mercury was discharged to sewer in 2017 as no waste of EWC 05 01 05, 06 or 12 was treated on site.

The site maintained its accreditations for ISO 9001, ISO 14001 AND BS OHSAS 18001. They will expire in October 2018.

Annual Report, Waste Transfer Station, MB3290HT

Targets for the waste transfer station are the same as those for the installation. There was no contamination originating from the waste transfer site.
