This site is not permitted to receive waste consigned under that code, however an application to vary the permit and add several waste codes, including this one, has been received by Natural Resources Wales (NRW).

Permission to conduct a small trial was given in CAR\_NRW0031872. Following the trial, NRW received the operating procedure and risk assessment for this activity. Both are acceptable and will ensure that there is minimal risk to the environment and human health.

**NRW therefore agree that Slicker may accept and treat waste consigned under EWC code 16 01 21\*. This agreement will remain in place until the varied permit is issued or until NRW decide that it is no longer appropriate.**
