Natural Resources Wales Officer Phil Harper Senior Industry & Waste Regulation Officer visited Refrigerant Transfer Operation Sandycroft, Factory Road, Sandycroft, Deeside, Flintshire, CH5 2QJ at 10:40 am on the 14th July 2022. This was an announced inspection which was accompanied by Paul Leadbetter, Technical Manager.

Weather conditions were bright and sunny.

B1 Engineering for Prevention and Control of Emissions

Impermeable surface was in good condition, with no signs of cracking.

No permit breaches identified.

C4 Storage Handling and Segregation

Incoming waste refrigerant was stored in sealed containers which were visibly in good condition.

Waste oils and wastes for incineration were securely locked in cages and provided with secondary containment.

No permit breaches identified.

F2 Noise

The site was operational at the time of the visit. On site activities were not deemed to be excessively noisy.

No permit breaches identified.

F3 Dust Particulates and Litter

No dust, particulates or litter observed from the site during the inspection.
