On the 11th of August 2019, I conducted a routine inspection of the Welsh Water Pumping Station at Parc Castell Y Mynach, permit number: AN0257901. The weather at the time of the inspection was dry.

Access to the site restricted, however I could hear pumps and there was clearly power at the site. There were no alarms going off. The outfall for the emergency overflow was not discharging and there was no evidence of sewage fungus or sewage litter in the watercourse.
