4. Details of our assessment

Review of emissions monitoring for period 1st January to 31st March 2022 (Q1)

Monitoring reports for emissions to air, water and sewer, and surface water/groundwater for Q1 were received on 29/04/22. This is the first full quarter where there are changes to the monitoring requirements brought about by the BREF review permit variation issued 01/11/21.

All emissions monitoring provided was compliant with the relevant emission limit values. However, the following deviation were noted:

- No quarterly monitoring of emissions to air for TVOCs and dust was provided as the Operator couldn't meet the MCERTs standard but suggests conformance will be achieved in Q2.
- Monitoring of emissions to air for ammonia and formaldehyde has not been completed to the standards required by the permit.
- Monitoring of emissions to water and groundwater for ammonia has not been completed to the standards required by the permit. This is currently the subject of a permit variation application from the Operator.
- Monitoring of emissions to water (W1) for BOD and suspended solids has not been completed to the standards required by the permit. ***Correction - BOD & suspended solid was completed to standard; reference e-mail 22/07/22 from Operator with updated W1 returns due to admin error.***

NRW considers this to be a breach of permit condition 3.5.1 (G1 Monitoring of emissions & the environment - C3).

ACTION: The Operator is to ensure Q2 and future monitoring returns meet the requirements of Condition 3.5.1 to include monitoring of all determinands to the standards required by 31/07/22.

Note - A16 & A17 monitoring of emissions to air only required 6 monthly and will be expected in Q2.
