3. What will happen next?

4. Details of our assessment

This was AST Plastic Containers UK LLPs first site inspection for permit ref EPR/CB3491FL which was carried out by Waste Regulation Officer Amy Henderson and Senior Waste Regulation Officer Steven White. As this was the sites first site inspection since being granted the permit, the inspection was pre-arranged and the operator was aware we would be attending.

On arrival at site, Officers met with Gavin Shepherd, site manager and Technically Competent Manager, who accompanied us throughout the visit. The first site inspection checklist was completed prior to a walk around of the site. Aspects of the permit including submitting waste returns, permit variations, public register details etc were explained. Waste returns for the site must be completed within one month of each quarter.

The site had commenced some operations under registered exemptions prior to the permit being granted. All operations are taking place within the building, as specified in the permit. The building contains areas for both recycling and manufacture of new containers.

The permit was granted with a condition that fire walls would be installed within the waste storage areas 1, 2, 3 and 4. These walls have been ordered but there has been a delay in them being installed due to supply chain delays. The site is hoping these will be installed within the next 6-8weeks. A report confirming these have been installed and to the correct specification must be submitted to Natural Resources Wales for written approval.

During the site inspection it was identified in that an IBC holding effluent from the washing plant was not double banded. An action was given to ensure a bund is put in place for this container.
