3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This Compliance Assessment Report follows a review of routine emissions monitoring returns for the period January - March 2022.

1. Emissions to Water

All emissions monitoring data supplied as required, emissions were within permitted limits with the exception of suspended solids measured at 268mg/l (ELV 250).

This emission limit exceedance has the potential for minor environmental impact and a non compliance score of 3 applies.

2. Emissions to Air

Emission Points A2, A3, A5, A6, A7, A20, A22, A23 & A24 (Acetic acid)

Emissions were compliant during this monitoring period.

Emission Point A14

A review of Continuous Emissions Monitoring data for this period has identified a number of Emission Limit Value (ELV) exceedances:

NO_x daily average (ELV 400mg/m³) exceeded 11/01/22 & 12/02/22.

CO half hourly average (ELV 100mg/m³) exceeded 04/01/22.

TOC half hourly average (ELV 20mg/m³) exceeded 04/01/22.

These emission limit exceedances have the potential for minor environmental impact and a non compliance score of 3 applies to each determinand for this quarter (3x CCS3 applied).

Dioxin measurements for July - December 2021 received 05/04/22 - emissions compliant.

3. Notifications

The Operator has not notified NRW of any of the above emission limit exceedances as

required by permit condition 5.1.1 and this attracts a non compliance score of 4.

Action 1 - Submit notifications for the emission limit exceedances (Air and Water) as required by permit condition 5.1.1 by 31/08/22. To include root cause analysis and steps taken to prevent a recurrence.

Action 2 - Review procedures to ensure emission limit exceedances are reported to NRW in accordance with permit condition 5.1.1
