4. Details of our assessment

On Thursday 14th July at 12:00 a permit inspection was conducted at Crownhill Topsoils at Caerwent Army Training Estate Permit Number **NB3597TA** by NRW officer Chris Burge and Greg Gardner, we met on site Simon Stone who conducted a site introduction and explained who the site operates, the weather was dry and sunny and around 20 degrees.

Simon Stone explained that this site is currently not being used to store or process material as there have been issues accessing the site due to military exercises taking place close by, Simon explained that he does plan to continue using the site.

The site contained one small pile of material that Simon explained was from a building that had been demolished and he was going to hand sort to remove good quality building stone.
