4. Details of our assessment

This CAR form is being issued following receipt of photographs from a Natural Resources Wales member of staff who was in the vicinity of Morfa Lodge on the 22nd of June 2022.

The photographs showed a discoloured discharge from the outfall from Morfa Lodge to the Foryd Estuary.

After receipt of these photos, contact was made by telephone with Andy Livingston at the site.

It's understood that a compressor had failed on the sewage treatment plant and that a reserve compressor had been fitted. Unfortunately it's understood that this reserve compressor was smaller in capacity and therefore the effluent wasn't as good as normal.

It was understood that a new compressor of adequate size was to be fitted on the 27th of June.

The matter was further discussed with James Livingston on the phone on the 22nd of July. The compressor had been replaced and was apparently working well.

It's noted that the permit to discharge for the site has a BOD (Biochemical Oxygen Demand) limit. It's suspected that if sample of the effluent had been taken on the day the issue was reported, it's likely to have breached the permit limit of 60mg/l.

In light of this incident (WIRS number 2204487), please review the condition of the plant and the availability of adequate spares to get through the peak summer months without further breakdowns.

Thank you for your co-operation to get this issue sorted.

The warning is due to the amenity impact seen in the photographs.
