4. Details of our assessment

Tony Bruten attended on Thursday 28th July and met with owner Mr Morgan.

Walk around site inspecting perimeter of buildings, drainage and yard maintenance. There were no non conformances identified although there was an area of concrete below the lower sheds that will need some maintenance at sometime to ensure no wash water enters the ground by seepage through cracks, this was discussed with Mr Morgan at the time.

No entry was made to the sheds as re Biosecurity regarding Avian Influenza.

Paperwork then inspected and BAT conclusion returns discussed. There were no non compliances identified.

No immediate further action required the only one thing to note is the small area of concrete below the lower sheds to be repaired.
