On the 13th of August 2019, I conducted a routine inspection of the sewage treatment system serving Cottrell Park Golf Club, permit number: NPSWQD006817. The weather at the time of the inspection was dry.

On arrival I met the general manager for the Golf Club. The sewage treatment plant is emptied every 3 months on a contract with Kingspan, records of maintenance up to date. The treatment plant has a visual alarm which can be seen from the site office and as such is monitored daily. There was no evidence of breakouts on the ground where the infiltration system is located. No odour issues.
