4. Details of our assessment

On Thursday 14th July at 10:30 a permit inspection was conducted at Crownhill Topsoils at Caerwent Army Training Estate Permit Number **BB3796HD** by NRW officer Chris Burge and Greg Gardner, we met on site Simon Stone who conducted a site introduction and explained who the site operates, the weather was dry and sunny and around 20 degrees.

Simon Stone gave NRW officers a full introduction to the site, how it operates and the processes they conduct, he also explained the testing undertaken on material, this is completed by a contracted company.

images 1 shows the weigh bridge all vehicles weighed on entry and exit from the site. all vehicle have to enter via security gate controlled by Ministry Of Defence



As we walked around the site Simon Stone explained all the materials and the process to recover the waste to become a product to sell.

Image 2 shows the processing trommel, this has changeable screens to process material to different sizes and grades



Images 3 is one of the storage sheds these sheds are used to store the material that has been processed and is now a product ready to be sold.
