Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This permit variation is for the continued permitted operation of a peak power electricity generation facility located at Aber Park Industrial Estate. The installation is made up of three natural gas-fired electricity generators (combined Medium Combustion Plant/Specified Generator) with a total thermal input of 16.848 MWth. This variation increases the operating hours of the three natural gas-fired electricity generators from 2000 hours per year to 2850 hours per year.
