### 4. Details of our assessment

On the 31st May 2022, we received a pollution report that there was a discharge immediately above

Bathing Water beach, during BW season, between 0100-0900.

Chris Roscoe, Environment Officer attended the site on that day. The hand held meter showed no adverse impact on the water quality. After further investigation an issue with the sewage pumping station was discovered. The discharge occurred as a result of SPS failure.

DCWW could not provide evidence that the failure of the SPS complied with the emergency event exemptions included in the permit.

This activity however has led to non-compliance of permit condition. This non-compliance report is issued with regards to the damage caused to the environment due to the pollution incident.

NRW requires you to take the following actions to avoid further damage to environment.

- Improve the infrastructure - repair assets and operations of pumping station
- Take necessary measures to resolve this issue and prevent further damage
- Prepare a accidental discharge plan to avoid future problems
- Comply with permit conditions
