4. Details of our assessment

On Thursday the 28th July 2022, officers Anna Wilmshurst and Hannah Goddard undertook a permit inspection of permit 21/58/44/0031 . Officers were met by manager Mike Watkins. The weather was dry and warm. This inspection was in response to recent dry weather triggering the hands off flow condition, specified in section 10.4 of the permit: 'No abstraction shall take place when the flow as measured by the compensation notch within the gateboard, at National Grid Reference SS 9489 8482 immediately downstream of the authorised abstraction point is equal to or less than 1.7 litres/second.'

Mike Watkins showed officers the ponds and explained that the abstraction is not in use, and that they pump water between the pools. Officers checked the point of abstraction (photo 1), which was not in use. No non compliances found. Officers left site at 12:45PM.
