4. Details of our assessment

PERMIT BREACH – TOTAL NITROGEN

Part of Permit Assessed - 3 Emissions

E3 - Emissions - Surface water C3 3.1.1, 3.1.2

Schedule 5 notifications have shown a breach of permit limit for effluent discharge from your facility into to the Afon Erch. The breach in question on this occasion is for total Nitrogen. This breach was sampled on the 19/07/2022.

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1 and S3.2

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for total Nitrogen is 20mg/l and the value reported was 26.1mg/l.
This result is less than 2 times the permitted limit and is therefore in the context of this discharge considered a minor breach.

The CCS score on this occasion is a CCS 3.

PERMIT BREACH – LATE REPORTING

The breach for total nitrogen was detected on the 19th July 2022 and not reported until the 29th July in breach of Schedule 5 and the permit condition below:

4.3 Notifications

(b) in the event of a breach of any permit condition the operator must immediately—
(i) inform Natural Resources Wales, and
(ii) take the measures necessary to ensure that compliance is restored within the shortest possible time;
