Wet Scrubber Replacement

Thank you for your email dated the 26th July 2022 detailing the planned replacement works for the wet scrubber plant associated with emission point A1.

Providing that the change is “like for like” and that the operating techniques and standards of the new equipment are similar and does not increase the environmental risk of the installation then Natural Resources Wales consider the proposal to be acceptable. Based on the information you have provided you will not be required to submit a permit variation or undertake air quality modelling.

Once you have had confirmation, please inform us of the exact start dates and on completion of the works.

If any potential or actual adverse environmental impact occur throughout the replacement works, please ensure that you notify us via the procedures listed within section 4.3 of your environmental permit (VP3635SY).
