Natural Resources Wales (NRW) will accept the Construction Quality Assurance (CQA) plan proposals for the construction of soil buttress subject to the caveats set out below.

- It is important that the operator ensures that robust and effective surface water management provisions, additional to the rain flaps, are maintained to limit any rain water runoff causing erosion at the crest of the buttress.

Please note that the acceptance of these CQA proposals, by NRW, does not mean that the assumptions, design specifications or testing regimes will be suitable for any future development at the site.
